

**REGULAR MEETING OF JULY 6, 2020**

---

Regular Meeting of the City Council was held remotely on Monday evening, July 6, 2020.

**CALL TO ORDER**

Council President Elizabeth Kazinskas called the meeting to order at 7:30 o'clock p.m.

**CALL OF THE ROLL**

City Clerk Alan Agnelli called the Roll of Members. Ten (10) Councillors were present including Councillors Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Elizabeth Kazinskas, Judy Mack, George Tyros, and James Walsh. Councillor James Boone was absent.

**OPENING PRAYER**

President Kazinskas led the Council in reciting the Opening Prayer.

**PLEDGE OF ALLEGIANCE**

President Kazinskas led the Council in reciting the "Pledge of Allegiance".

**OPEN MEETING RECORDING & PUBLIC RECORDS ANNOUNCEMENT**

President Kazinskas announced that pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §20, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Gardner City Council will be conducted via remote participation and broadcast live on Gardner Educational Television, Channel 8, and on the City's YouTube Channel. The audio or video recording, transcript, or other comprehensive record of proceedings will be posted on the City's website as soon as possible after the meeting. She added that since the meeting is being conducted via **Zoom**, that all votes taken would be by roll call and asked Councillors to raise their hands to be recognized.

**READING & ACCEPTANCE OF MINUTES**

On a motion by Councillor Ronald Cormier and seconded by Councillor James Walsh, on call of the roll, it was voted ten (10) yeas, President Elizabeth Kazinskas and Councillors Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Judy Mack, George Tyros, and James Walsh, to waive reading and to accept the Minutes of the June 15, 2020 Regular Meeting, as printed.

**PUBLIC HEARING****#10288**

President Elizabeth Kazinskas opened the Public Hearing on a Petition by National Grid for permission to install 197' of conduit starting at 370 Park Street and heading north to Pole 40 Clark Street.

The President called for persons wishing to testify in favor of the Petition.

Robert Williams, representing National Grid, testified that the conduit provides infrastructure and interconnection points for EG services in the Gardner area.

Councillor James Walsh questioned Mr. Williams, noting that the Petition seeks to authorize 197 feet of conduit at approximately 370 Park Street northerly to Pole 40. Back on October 7, 2019, he said, the Council passed an Order for electric conduit on the Petition by National Grid for a length of 1,100 feet of conduit starting at 370 Park Street heading north to Pole 1 on Clark Street. He noted that the new Petition seeks to place conduit beginning at the same place to run in the same direction for 197 feet instead of 1100 feet, so he questioned if the new Petition is a substitution for the first Order.

Mr. Williams responded affirmatively, saying that National Grid needs only 197 feet of conduit to Pole 40.

Councillor Walsh suggested that under "New Business," he intends to propose rescinding the original Order, Council #10165, "assuming that the new Petition is granted."

The President twice called for persons wishing to testify in favor of the Petition.

There being none, the President thrice called for persons wishing to testify in opposition.

Councillor Graves informed the President that he is monitoring Facebook and that Judy Tysinger, an Abutter, is attempting to log in but that "it won't accept."

Councillor Walsh suggested that since there is nothing else to be done at this point, that the Public Hearing be suspended while the resident attempts to join the meeting and, if successful, the President could then reopen the hearing.

President Kazinskas suspended the Hearing at 7:39 p.m.

**\*\*During the suspended portion of the Hearing, discussion continued under #10288, Public Service Committee Reports.**

At 7:47 p.m., President Kazinskas reopened the Hearing since abutter Judy Tysinger was able to log into the Zoom meeting.

Judy Tysinger, 323 Park Street, expressed opposition to the Petition. She said that the Plan accompanying the Petition did not correspond, as the Petition indicated that the underground conduit would begin at 370 Park Street, but that the Plan indicated otherwise. She added that this has been consistent with National Grid, "they tell the City one thing and then do something else."

President Kazinskas questioned Councillor Boudreau, Chairman of the Public Service Committee, asking whether the Committee was notified that there was a typographical error in the Petition – that the address should read “307 Park Street,” instead of “370 Park,” – and that all of the Abutters were contacted.

Councillor Boudreau concurred, saying that there was an issue with the address.

President Kazinskas suggested that the address be noted as “307 Park Street.”

Mrs. Tysinger said that she wasn’t notified that there was change in the address, that there was an error.

Councillor Walsh moved to amend the Petition to read “307 Park Street.”

Councillor Boudreau seconded the motion.

On the motion, Councillor Mack informed the Council that the Public Service Committee amended the Petition to “307” at its meeting.

President Kazinskas questioned whether all abutters were notified of the Hearing, regardless of whether the Notice stated “370 Park versus 307.”

The City Clerk responded, “That is correct.”

Councillor Walsh stated that he appreciated that the Public Service Committee recommended that it be amended to “307,” but what is before the Council is “370” and the Petition needs to be amended to “307” by the Council.

Councillor Graves questioned Councillor Walsh’s comments, asking if he means that the Petition be postponed until the next meeting.

Councillor Walsh replied, saying that he is recommending that the Petition be amended from “370” to “307,” as the Council has to act on it as that is the item before it. “Assuming that it is amended, I don’t see the reason for it to be postponed,” he added.

Councillor Graves said that his only question would be whether or not the notice to the abutters would be valid or proper because the notice read “from 370 Park Street.”

Councillor Boudreau said that the Clerk and DPW Director advised that all abutters were notified; however, he would not be opposed to re-notifying the abutters with the correct address information since it is a substantial change.

Councillor Mack stated that the Petition error was brought to the Clerk’s attention today “to make sure this is correct.” She read the response from NGRID, as follows: “I don't see the address

being 370 as be[ing] a problem. The original petition of 1100' was approved using the same address. All this address typo will have done is over inform homeowners outside of what is actually required." Councillor Mack added that she disagrees because "obviously 307 to 370 is outside" the address range.

Citing the NGRID Plan, Councillor Dernalowicz suggested that 307 Park Street seems to be in the middle of the proposed conduit, so the issue needs to be addressed prior to re-noticing the public hearing.

Councillor Graves said that he appreciated the information from Councillor Mack that National Grid is incorrect. He asked if Mrs. Tysinger was provided with the revised plan by the DPW and questioned whether her objections are due to the planned construction or because the notice wasn't correct.

Judy Tysinger said that they were notified of "370 Park to Clark Street" and not notified that there would be construction in front of her house and what is [shown] on the map, "which is different than what is stated [on the Petition]."

Councillor Walsh suggested that the Hearing be postponed until the next appropriate meeting and that a new notice be sent to the Abutters and which would provide the Clerk with an opportunity to send notices based on the "307 Park Street" address.

Mr. Williams said that National Grid's sketches indicate that the beginning of the conduit is not in front of 370 Park Street, but that "Pole 40 is more in front of 307 Park Street."

On a motion by Councillor Walsh and seconded by Councillor Graves, on call of the roll, it was voted ten (10) yeas, President Elizabeth Kazinskas and Councillors Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Judy Mack, George Tyros, and James Walsh, to amend the Petition description to read: "... starting at 307 Park Street and heading north to Pole 40 Clark Street."

Councillor Walsh moved to postpone the hearing and action to a future date, whether regular or special meeting, after the amended/corrected notice is issued.

Councillor George Tyros seconded the motion.

The City Clerk informed the Council that a seven-day notice is required to abutters and that a revised Plan would be sought from National Grid, one that would provide abutters with clearly-defined boundaries.

Councillor Graves questioned whether there is any urgency to the Petition, expressing concern that some residents could be affected by a delay in the Council's approval of the Petition.

Mr. Williams responded, saying that the conduit would serve EG sites in particular (solar purposes).

Councillor Walsh stated that he believed that the particular solar array [to be serviced by the conduit] is at the Fish and Gun Club and added that the continued hearing could be conducted along with the second Petition (#10296). He also noted that in the past, the City Engineer signed-off the Petition.

On the motion, on call of the roll, it was voted ten (10) yeas, President Elizabeth Kazinskas and Councillors Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Judy Mack, George Tyros, and James Walsh, to postpone the hearing and action to a future date – regular of special – after the amended/corrected notice is issued.

**PETITIONS, APPLICATIONS, COMMUNICATIONS, ETC.**

**#10295**

President Kazinskas announced that she would recuse herself from participation and voting on Calendar #10295 due to a potential conflict. She called upon Councillor James Walsh to assume the Chair and then stepped down.

On a motion by Councillor Craig Cormier and seconded by Councillor George Tyros, on call of the roll, it was voted nine (9) yeas, and Councillors Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Judy Mack, George Tyros, and James Walsh; one (1) excused, President Elizabeth Kazinskas, to refer *An Application by Gardner Ten Pins, Inc., 560 West Broadway, for Renewal of a Bowling Alley License* to the Public Safety Committee for study and report.

Councillor Walsh stepped down and President Kazinskas resumed the Chair.

On a motion by Councillor Nathan Boudreau and seconded by Councillor Judy Mack, on call of the roll, it was voted ten (10) yeas, President Elizabeth Kazinskas and Councillors Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Judy Mack, George Tyros, and James Walsh, to refer *A Petition by National Grid for permission to install 6 SO poles on Clark Street beginning at a point approximately 25' northwest of the centerline of the intersection of Racette Avenue and Clark Street and continuing approximately 700' in a northwest direction* to the Public Service Committee for study and report and to schedule a Public Hearing.

REPORTS OF STANDING COMMITTEESPUBLIC SERVICE COMMITTEE**#10288**

Councillor Nathan Boudreau, Chairman of the Public Service Committee, reported that the Committee voted in favor of recommending that the *Petition by National Grid for permission to install 197' of conduit starting at 370 Park Street and heading north to Pole 40 Clark Street* be granted with the condition that wherever the ground is broken, that they repair "from berm-to-berm." He said that he "is hesitant to make the recommendation since the resident has loudly made her opinions heard over the last couple of weeks and has not had the opportunity to speak on the record." "But," he said, "I'll leave it in your favor and move to approve the Petition with the condition that the company repairs the street from berm-to-berm as it has been completed in the last five years, per City Ordinance."

Councillor Boudreau then moved to grant the Petition of National Grid for permission to install 197' of conduit starting at 370 Park Street and heading north to Pole 40 Clark Street.

Councillor Graves seconded the motion.

On the motion, Councillor Walsh questioned whether there has been any indication that the resident has been able to participate in the hearing. "If not," he said, "I leave it to the Council President's discretion as to whether to hold over the hearing until the next meeting or anticipate that there may be one or more special meetings before the next regular meeting." He said that the item may be added to one of the special meetings, so that the resident may have the opportunity to participate in the public hearing.

President Kazinskas agreed, suggesting that the hearing be continued to allow the resident to be heard.

Councillor Walsh moved to continue the matter until the next special or regular meeting.

Councillor Boudreau seconded the motion.

Councillor Karen Hardern informed the President that she had a message from Judy Tysinger saying that she is able to log into the meeting.

Councillor Graves informed the Council that Judy Tysinger is telling him the opposite. "We gave her Mr. O'Keefe's phone number to call him and she said that it will not let me call and then trying to connect with the correct Zoom number and not able to get in," he said.

Councillor Walsh suggested that the delay will give the resident an opportunity to send written documentation, in addition to having the opportunity to participate in the public hearing at the next meeting.

At this time, Mrs. Tysinger was able to log in and the Council President reopened the Hearing (**PUBLIC HEARING, #10288**).

**NEW BUSINESS**

Councillors expressed their appreciation to Council President Kazinskas for “a great job” in her dual role as Acting Mayor.

Councillor Craig Cormier extended “kudos” to the City Clerk’s staff and election officials for a very successful election.

Councillor Walsh informed Councillors that he had planned to seek rescission of the Order granting National Grid permission to construct 1100 feet of conduit starting at 370 Park Street and heading north to Pole 1 Clark Street, adopted on October 7, 2019 under Calendar #10165); however, since the Hearing has been continued, that he will seek to include the Measure on the August 3, 2020 Council Calendar.

Councillor Walsh congratulated Michael Nicholson on his recent election as Mayor and credited all candidates for placing their names on the ballot, adding that it takes courage to do so.

**CLOSING PRAYER**

President Kazinskas led the Council in the Closing Prayer.

**ADJOURNMENT**

On a motion by Councillor Craig Cormier and seconded by Councillor Nathan Boudreau, on call of the roll, it was voted ten (10) yeas, President Elizabeth Kazinskas and Councillors Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Judy Mack, George Tyros, and James Walsh, to adjourn at 8:13 p.m.

expenses vary year-to-year. The Auditor reported that the deficit currently stands at \$271,600; however, the DPW Director expects additional invoices bringing the final deficit to \$275,000. Councillor Ronald Cormier added the DPW Director reported that the current Fiscal Year's expenses are about \$5,000 less than last year.

Reporting for the Finance Committee, Councillor James Walsh informed the Council that the Committee voted to recommend passage of the Order. Citing the DPW Director's letter, he reported that the Department reduced the line item for street lights in anticipation of lower rates for LED street light installations. He said that the City was billed at the higher rates since National Grid had not established rates for the LEDs and that the City is expecting a significant reimbursement for the time that the City has been online with the LED lights, which is about \$57,000.

Councillor Boone questioned where the reimbursed funds are deposited.

Councillor Walsh stated that he believes that the reimbursement falls to the General Fund.

City Auditor John Richard stated that the reimbursement is deposited into the General Fund and then fall to Free Cash in the following year. He added, however, that he does not anticipate receipt until the next Fiscal Year.

On a motion by Councillor James Walsh and seconded by Councillor Ronald Cormier, on recommendation of the Finance Committee, it was voted on call of the roll, ten (10) yeas, President Elizabeth Kazinskas and Councillors James Boone, Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Karen Hardern, Judy Mack, George Tyros, and James Walsh; one (1) nay, Councillor Scott Joseph Graves, to adopt the following Order:

Reporting for the Finance Committee, Councillor Ronald Cormier informed the Council that the Committee met with the Fire Chief who reported that overtime expenses are due to 5 resignations this year and only 3 were hired as replacements. He added that 1 Lieutenant is out injured and will be retired at the end of June. He said, as pointed out, the Department has a minimum manning clause that requires 1 Lieutenant and 7 firefighters on each shift; therefore, every shift requires overtime.

Councillor James Boone noted that very year there is more overtime and questioned where the salaries go if people resign.

Councillor Ronald Cormier responded, saying that the wages are paid to the firefighters filling the shifts, plus overtime. He added that another problem is that it takes a long time to get new recruits into the Fire Academy and for certification, all before a firefighter can start.

Councillor James Boone suggested that the City is paying a higher rate because veteran firefighters are being paid at the overtime rate.

Councillor Ronald Cormier stated that overtime is predicated on the salary that the [particular] firefighter receives.

Councillor Scott Graves stated that he communicated with the Fire Chief and that the Department has experienced resignations primarily because of the low pay.

On a motion by Councillor Ronald Cormier and seconded by Councillor James Walsh, on recommendation of the Finance Committee, it was voted on call of the roll, eleven (11) yeas, President Elizabeth Kazinkas and Councillors James Boone, Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Judy Mack, George Tyros, and James Walsh, to adopt the following Order:

Councillor Walsh responded, saying that Termination Leave is a reserve account that serves all the different departments and is the method that the Mayor in prior years has chosen to budget for termination leave.

City Auditor John Richard stated that the \$200,000 was budgeted for the Fiscal Year; however, some employees provide little advanced notice of when they plan to retire.

Councillor Mack questioned "all departments," as the School Department has its own budget for termination leave.

Mr. Richard stated that the School Department has its own budget and that the [Termination Leave] Reserve account covers only City [municipal-side] employees.

On the motion, Councillor Scott Joseph Graves informed the Council that he sent a referral to the Finance Committee because some Councillors had been talking about the 1/12<sup>th</sup> Continuing Appropriation Budget. He said that his question went back to the end of March and “whether or not a 1/12<sup>th</sup> Budget is a good idea.” “My question,” he said, “given the language of the statute, which is Chapter 44, section 32, whether the Acting Mayor had any authority to recommend – because it has to come from the Mayor – the language of the statute says that the Continuing Appropriation Budget ... has to come from the Mayor ... because we didn’t have a Mayor, my question has been and still is ... I know the Finance Committee dealt with it and kind of resolved this on their own ... that’s why we don’t see my referral on the City Council agenda.” “But the question still is ... now I understand on June 6, after my referral, the State Senate passed Bill S. 2680, which is subject of City Solicitor Flick’s Memorandum. That doesn’t change anything because that Senate language is exactly the same as the language of Chapter 44, section 32. The only difference is that if the elected Mayor was not able to do the Budget and was not able because of COVID, the Senate says that time is going to be extended.”

Continuing, Councillor Graves stated, “But, it’s never been our issue as to why we weren’t going to get the Mayor to do a budget. The reason why we weren’t going to get the Mayor to do a budget is because the Mayor left without doing a budget. So, we never had the elected Mayor doing the budget. So the Senate bill doesn’t help us with this one question – ‘Does the Acting Mayor have the authority to do this what we’re doing tonight?’” “And,” he continued, “I understand what Councillor Walsh said at the Finance Committee meeting and he’s correct that it’s Acting Mayor Kazinskas’ discretion and that is what she’s exercising now. So I just wanted to point out that is the reason for my referral.” “And,” he continued, “I think I also agree with Councillor Walsh when he says at the Finance Committee meeting that it’s preferable to do a 1/12<sup>th</sup> Budget as opposed to the City Council doing a budget, because again, and that is the question why I didn’t think – I was wondering whether or not it was an emergency by the Acting Mayor because the law says that the City Council ... and John Richard and I had some conversations on this ... and it’s crystal clear that the law says that the City Council has the authority to do the budget itself if the elected Mayor doesn’t do it. And that is exactly the situation we have.” Continuing, Councillor Graves said, “So, given the fact that the law gave us this out ... it was just questionable to me to whether or not the Acting Mayor had a ‘matter not admitting of delay’ because the City Council had an option.”

Concluding, Councillor Graves said, “So, that’s a long way to say the reason for my question, but I do agree with the Finance Committee meeting that I think it’s preferable that we do it this way as opposed to the City Council doing the entire Fiscal Year 2021 Budget. But, just because something’s preferable, doesn’t mean that you can overrun the law.”

Councillor George Tyros expressed support and believes “there is an argument that we do not have an elected Mayor due to COVID because we would have had the election process completed by now,” so that’s why my logic says its preferable to go in this manner.”

citizenry when we get documentation and get communication from the citizenry. It gives us a great indication as to how people feel about things.” He said that he hoped everyone had a chance to read the Petition and to look at the names. “And I appreciate that. I’m not saying how I feel about the issue right now because it’s very early in the process, but I do appreciate the communication and the petition,” he added.

Councillor James Boone stated that he browsed through some of the signatures on the petition and noted names from Austria and New Zealand. He expressed agreement with Councillor Graves that “we are looking out for the best interest of where they live and how to enjoy their peaceful time,” but that he “doesn’t get why people from across the world have a say to what’s going on.”

On a motion, on call of the roll, it was voted eleven (11) yeas, President Elizabeth Kazinskas and Councillors James Boone, Nathan Boudreau, Craig Cormier, Ronald Cormier, Aleksander Dernalowicz, Scott Joseph Graves, Karen Hardern, Judy Mack, George Tyros, and James Walsh, to place on file Correspondence from Roxanna Figueroa relative to the proposed Bailey Brook Park and Conservation Area.

#### NEW BUSINESS

Councillor James Boone expressed concern that the legislature did not take any action to postpone the layoffs and cuts that are happening to the school districts all across the state. He said that it is really disappointing that they didn’t allow that extension to delay pink slips. He noted that there were 76 school personnel cut in Winchendon.

Councillor Scott Graves informed the Council that another referral to the Finance Committee concerned “the open meeting spirit of government transparency” and making sure that the public knows what’s going on in its government. He said that his referral related to a public records request that stemmed from an incident where a citizen requested a certain document in December while he was Council President. He said that the document was provided by the City Solicitor and that the words “Attorney-Client Communication” were written on it and, for that reason, when the document came to the Council, he had the Clerk get input from the Law Department to find out what the Attorney-Client situation was about as he [Councillor Graves] didn’t agree that it was “Attorney-Client privilege.” He said that after Councillor Walsh became Council President, he “never heard from it again,” but learned that the citizen went through the Supervisor of Public Records to appeal the City Solicitor’s response, but in the end, the Supervisor of Records accepted the City Solicitor’s opinion that it was “Attorney-Client Privilege.”

Continuing, Councillor Graves stated that a referral comes to the City Council, that it should be answered by the City Council. “Now,” he said, “I think Councillor Walsh was confused at the Finance Committee meeting because he said, that I said ‘That the City Clerk cannot obtain

the assistance and involvement of the Law Department' and that I said 'It is not appropriate for him to do so.' I never said that. You can read my referral, it's in black and white." "What I said was 'he can have all the input he wants, but it's the City Council that has to answer the records request -- it's on us, we are the legislative body of the government.'" Councillor Graves continued by citing 950 CMR 32 which, he said, says "the Clerk can designate RAO's, but that he [Clerk] has to list the RAOs, but the Clerk never picked John Flick in this instance." "I was hoping the Finance Committee would agree with me," he added.

Concluding, he said that if Atty. Flick says the document is "Attorney-Client Privilege," the City Council is the client and only the client can assert and waive the Privilege. "That's our [Council's] domain," he added.

Councillor Judy Mack stated that, to her knowledge, the Gardner Public Schools did not recommend cuts or issue pink slips, but others like Quabbin, Ash-West, and Winchendon were hit tremendously. In addition, she stated that the concerns and presence of the residents of Leo Drive on the issue speaks volumes and that the Council is listening. She also encouraged voters to obtain early ballots for the June 30 special election soon.

Councillor James Walsh concurred with Councillor Mack's remarks and people receiving ballots to promptly respond to them. Referencing Councillor Graves' remarks, Councillor Walsh said that in addition to the Clerk having the right to designate other Records Access Officers, he and any other municipal employee or Records Access Officer have the right to seek the Law Department's input.

Council President Kazinskas stated that the residents of Leo Drive and Brookside Drive have done a fantastic job communicating their opinions concerning Baily Brook Park and that her role is to advocate for them as Ward Councillor and also by relaying their information and concerns to the relevant staff in the Community Development and Planning office.

**CLOSING PRAYER**

President Kazinskas led the Council in the Closing Prayer.

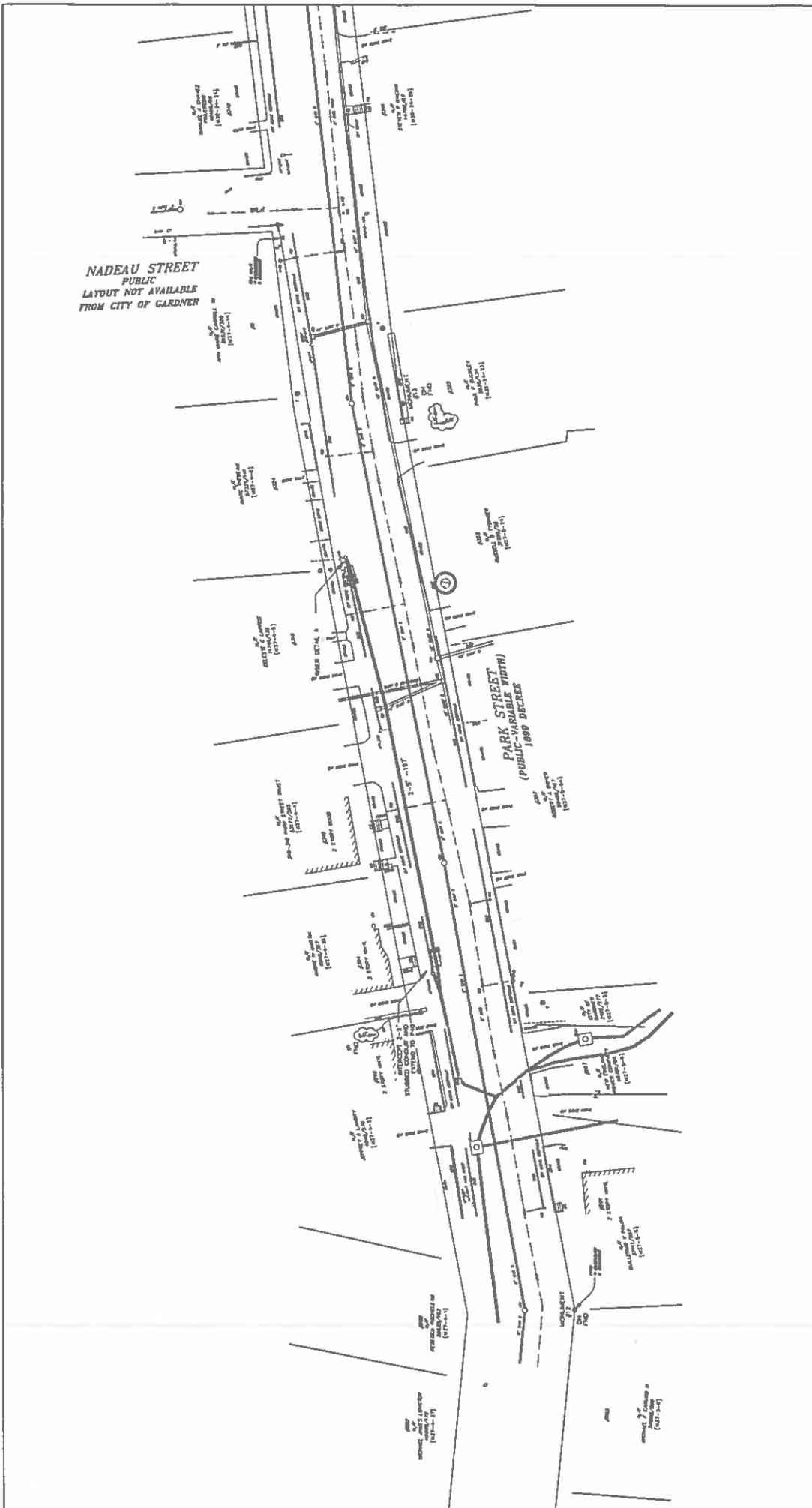
